**Call to Order**

**Approval of Last Meeting Minutes**

Expenses for September were \$10.00 for licenses and \$61.17 for office supplies. Sherri Wagner made a motion to accept the Treasurer's report with a second from Jim Wagner. The motion passed.

**Invoice Approval for Payment**

An invoice for mailing expenses for \$12.32 from Sherri Wagner was presented. Jim Wagner made a motion to pay the premium for board of directors insurance for October to December in one lump sum and for the mailing receipt with a second from Mark Peter. This was carried.
